### KSA Meetings Held between Board meetings.

**Senator Rand Paul** Spoke about the George Floyd act, qualified immunity, Justice Reform, body cameras, and 1033 program. Well attended by KY Sheriffs from the west. The meeting was held in Owensboro.

**Rep. Steven Rudy** meeting in Paducah with several WKY Sheriffs. Issues discussed was court pay, out of state inspections, and other sheriffs' issues.

**Upcoming** meetings will be held with Rep Massey and Senator Chris McDaniel.

**Fingerprint meeting** with KSP-KSP signed a 3-year deal with IDENTAGO for fingerprinting service. Previous Governor Bevins wanted a quicker method to have fingerprints processed. Sheriff Sholar will be looking into this issue.
